Ease of Use


A great deal of our development efforts have focused on making it easy for every participant to focus on the proceeding rather than the technology.



Our remote equipment kit is easy to set up. The system needs only three cables and a connection to the Internet. The system
includes separate monitors for the video feeds, a shared view of the evidence being presented, and access to documents and
real-time transcript, tailored to each participant's role. Once online, it's managed remotely by our hosting team.

FTI's TrialMax Cloud® platform serves as an integrated portal for access to the documents before and during the hearing, along with secure access to the hearing itself, with appropriate entry points for the key participants and the gallery.

Security & Privacy

When FTI hosts a proceeding, we ensure technical security and managed access to ensure confidentiality. Our remote equipment kit offers secure, virus-free access to the proceeding for even the least technically-adept participants. We also offer an optional 360° camera, allowing Counsel to observe the witnesses' environment during testimony.

Reliability & Efficiency

One of our most important roles is to keep the proceeding running smoothly. FTI coordinates with all participants before the hearing and arranges for equipment needs and access to TrialMax Cloud® for secure document sharing. We also provide pre-proceeding training to ensure comfort with the technology. FTI monitors, supports and troubleshoots the video conferencing system throughout the proceeding and remotely log in each witness, prior to the start of their testimony, to eliminate any last-minute technical issues.

Our hosting team has remote access to all of our remote equipment kits to ensure each user has appropriate, uninterrupted access to the video display, the evidence display, and TrialMax Cloud®.

FTI offers evidence presentation services ("hot seat" support) to guarantee that everyone is looking at the same view of the evidence, just as in a traditional hearing.



Multilingual Accommodations

Remote conferencing platforms offer an environment well suited to live interpretation. A good web hosting platform, such as Zoom, allows participants to individually choose how they want to balance audio volume between the speaker's and listener's language – making it easy to understand both the words and intonation of the speaker.

Preserving the Record

FTI offers simultaneous software and hardware recording and backup solutions to ensure a reliable record is preserved. We can make the recordings quickly available to the court reporter/transcription provider, through TrialMax Cloud®, for use in confirming the written record.
